What is being covered?

This two-day webinar will cover Creditable Service, Creditable Compensation, and Defined Benefit Membership.

Creditable Service is the foundation of reporting to CalSTRS. This module covers the requirements positions must meet to be creditable to CalSTRS.

Creditable Compensation covers conditions that make compensation creditable, the differences between salary and special pay, and how to report compensation to CalSTRS.

Defined Benefit Membership shows how an employee becomes a CalSTRS member, or what happens if they are already a member. This module covers great information about submitting enrollment forms and deadlines.

Who should attend?

This training is applicable to new employees who are looking for their foundation in reporting to CalSTRS and more seasoned staff who are looking to reinforce their knowledge. We highly recommend including both HR and payroll staff as the topics are interconnected, and a shared understanding may reduce reporting errors.

When is the event?

There will be two upcoming sessions available during Winter and Spring and both will be two-day webinars.
