1. Introduction

This *F496 Error Resolutions* is a resource to instruct users on how to resolve F496 errors that occur when processing an F496 File in the new Secure Employer Website. This file must be free of errors before it can be submitted to CalSTRS. This document provides the business rules including resolutions that are applied to an F496 File.

1.1 Purpose

The F496 File has four error types that can occur when processing a file:

- 1. File Formatting Errors: Structural issue with the file such as an invalid character.
- 2. Business Errors: An error that must be fixed before the file can be submitted for posting.
- 3. **Warnings:** An error that must be fixed or validated with a comment before the file can be submitted for posting.
- 4. **Informational Messages:** A potential error that does not require correction in order to submit for posting.

2.0 F496 File Formatting Errors and Resolutions

Error Message ID: 30301075

Legacy Error ID: MO-I002

Error Description: Invalid Pay Period Begin.

Error Resolution: The Pay Period Begin field contains non-numeric characters or invalid dates. The Pay Period Begin field can only contain numbers (i.e. 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) and cannot start with a zero. Invalid dates include using months outside of 1 through 12, days that exceed the amount allotted in a month (e.g., February 30, January 32, etc.). Valid Pay Period Begin can only contain date serial numbers as date values in MM/DD/YYYY format.

Verify with your payroll data and update the Pay Period Begin with valid date values and date formats in your file or in your payroll system.

- If correcting your file, update the Pay Period Begin field with valid date values and date format. Re-upload corrected file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update Pay Period Begin with valid date values and date format. Upload a new file into SEW.

Field(s) and Record Position(s): Pay Period Begin (64-71)

Error Message ID: 30301076

Legacy Error ID: MO-I003

Error Description: Invalid Pay Period End.

Error Resolution: The Pay Period End field contains non-numeric characters or invalid dates. The Pay Period End field can only contain numbers (i.e. 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) and cannot start with a zero. Invalid dates include using months outside of 1 through 12, days that exceed the amount allotted in a month (e.g., February 30, January 32, etc.). Valid Pay Period End can only contain date serial numbers as date values in MM/DD/YYYY format.

Verify with your payroll data and update the Pay Period End with valid date values and date formats in your file or in your payroll system.

- If correcting your file, update Pay Period End field with valid date values and date format. Reupload corrected file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update Pay Period End with valid date values and date format. Upload a new file into SEW.

Field(s) and Record Position(s): Pay Period End (72-79)

Error Message ID: 30301077

Legacy Error ID: MO-I004

Error Description: Pay Period Begin greater than Pay Period End.

Page 4 of 79

Error Resolution: The Pay Period Begin field and Pay Period End field contain valid dates; however, the Pay Period Begin date is greater than the Pay Period End date. Pay Period End date cannot be before the Pay Period Begin date (e.g., Pay Period Begin 11/15/2007 and Pay Period End 11/13/2007).

Verify with your payroll data and update your file or your payroll system with the Pay Period Begin date to be prior to and not greater than the Pay Period End date.

• If correcting your file, update the Pay Period Begin date to be prior to and not greater than the Pay Period End date. Re-upload corrected file into SEW.

• If correcting your payroll system, make the appropriate changes in your payroll system to update Pay Period Begin date to be prior to and not greater than the Pay Period End date. Upload a new file into SEW.

Field(s) and Record Position(s): Pay Period Begin (64-71), Pay Period End (72-79)

Error Message ID: 30301079

Legacy Error ID: MO-I006

Error Description: The Report Unit/Source in the file does not match with the Report Source indicated when the file was uploaded.

Error Resolution: The Source Code and Unit Code within the file are valid codes in the system, however do not match with the Reporting Source of the SEW user who uploaded the file.

Verify the Source Code and Unit Code match to the appropriate Organization that has been selected upon SEW log in.

If the SEW user is logged in under the incorrect Organization:

- Switch to the appropriate Organization by using the "Select Organization" icon at the top of the screen.
 - If you do not have access to the Organization contact your Admin to ensure you have the appropriate permissions.

If the Organization Code in the file does not match to the correct Organization that has been selected upon SEW log in update the Organization Code:

- If correcting your file, update the Source Code and Unit Code fields to match the Organization Code of the SEW user who uploaded the file. Re-upload file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update Source and Unit Codes. Upload a new file into SEW.

Note: The 2-digit Source Code and 3-digit Unit Code are combined and validated against the 5-digit Organization Code in the system.

Field(s) and Record Position(s): Source Code (80-83), Unit Code (84-86)

Error Message ID: 30301078

Legacy Error ID: N/A (Consolidates MO-I006, MO-I008 and MO-I027)

Page 5 of 79

Error Description: The Reporting Source Code and/or Unit Code is invalid or does not match the codes in the system.

Error Resolution: The Source Code field and/or Unit Code field is invalid, not found, or does not match with an Organization Code in the system. A Source Code or Unit Code field cannot be blank and can only contain numbers (i.e. 1, 2, 3, 4, 5, 6, 7, 8, 9, 0).

If blank or invalid, update the F496 contribution file or your payroll system with the correct Source Code and/or Unit Code and re-upload the file into SEW.

If the Source Code/Unit Code is valid, CalSTRS may not have a record of this Organization Code within the system. Contact CalSTRS Employer Help if you believe this is a valid Organization Code.

Note: The 2-digit Source Code and 3-digit Unit Code are combined and validated against the 5-digit Organization Code in the system.

Error Message ID: 30301040

Legacy Error ID: MO-I017

Error Description: Invalid file format. Record identifier is not defined in the file layout.

Error Resolution: The Line Type Code must be L (Contribution Line), P (Page Total Line), D (District Total Line) or C (County Total Line). Verify Line Type Code is valid. If incorrect, change the Line Type Code to indicate the line type being reported.

- If correcting your file, update the Line Type Code to a valid value. Re-upload file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update Line Type Code. Upload a new file into SEW.

Field(s) and Record Position(s): Line Type Code (90) (Contribution Line), Line Type Code (83) (Page, District and County Total Line)

Error Message ID: 30301080

Legacy Error ID: MO-I020

Error Description: The Fiscal Year does not contain a valid numeric value or does not equal to the Fiscal Year of the Reporting Period.

Error Resolution: The Fiscal Year field value is invalid, contains non-numeric characters, or does not match the Fiscal Year of the Reporting Period.

The Fiscal Year field value cannot be blank, cannot contain special characters, can only contain numbers (i.e. 1, 2, 3, 4, 5, 6, 7, 8, 9, 0), and must be in YYYY fiscal year format. The fiscal year must match the fiscal year of the Reporting Period selected at upload.

Example: If Reporting Period selected is 02/01/2018 - 02/28/2018 upon file upload, the fiscal year on

each data line must be 2018. If Reporting Period selected is 08/01/2018 - 08/31/2018, the fiscal year on each data line must be 2019.

- If correcting your file, change the Fiscal Year to match what was selected when the file was uploaded. Re-upload file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to match the Fiscal Year that was selected when the file was uploaded. Upload a new file into SEW.

Field(s) and Record Position(s): Fiscal Year (1-4)

Error Message ID: 30301081

Legacy Error ID: MO-I021

Error Description: Employee Social Security Number does not contain a valid numeric value.

Error Resolution: Employee Social Security Number field is invalid or contains non-numeric characters.

The employee Social Security Number cannot be blank or cannot contain special characters. A valid Social Security Number can only contain exactly 9-digit numbers (i.e. 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) without dashes or blanks.

Verify employee Social Security Number.

Update your file or your payroll system with verified and correct employee Social Security Number.

- If correcting your file, enter verified and correct employee SSN. Re-upload file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update verified and correct employee SSN. Upload a new file into SEW.

Legacy Error ID: MO-I023

Error Description: The Pay Rate does not contain a valid numeric value (signed or unsigned).

Error Resolution: The Pay Rate field contains an invalid value.

The entire Pay Rate field must contain all valid numeric values (signed* or unsigned). A valid Pay Rate must have all signed values in uppercase per Table 1: Signed values conversion table below.

The Pay Rate field in signed/unsigned value has its rightmost digit converted into a sign representation character. Refer to Table 1: Signed values conversion table for the following examples:

- 1. A positive 6-digit fixed positional text value of '654321' can either be represented by '654321' or '65432A', where the rightmost digit was replaced with 'A' to represent a value of 1, and that entire value is positive.
- 2. A negative 6-digit fixed positional text value of '-654321' must ONLY be represented as '65432J', where the last digit was replaced with 'J' to represent a value of 1, and that entire value is negative. Negative pay rates are converted into positive pay rates after sign conversion.

Error Message ID: 30301083

Legacy Error ID: MO-I024

Error Description: Earnings does not contain a valid numeric value (signed or unsigned).

Error Resolution: The Earnings field value is invalid, or does not contain a valid signed/unsigned value.

The entire Earnings field must contain either all valid numeric values (signed* or unsigned) or be blank (blank if Contribution Code 2 and RWP only). Valid Earnings must have all signed values in uppercase per Table 1: Signed values conversion table below. Earnings field can be blank for RWP only with Contribution Code 2.

- If correcting your payroll system, make the appropriate changes in your payroll system to update the Earnings field with valid numeric values (signed or unsigned). Upload a new file into SEW.

Field(s) and Record Position(s): Earnings (46-52)

Error Message ID: 30301084

Legacy Error ID: MO-I025

Error Description: The Member Contribution Rate (Post-Tax) does not contain a valid numeric value (signed or unsigned).

Error Resolution: The Member Contribution Rate (Post-Tax) field does not contain a valid numeric value.

The entire Member Contribution Rate (Post-Tax) field must contain either all numeric values (i.e., 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) or be blank. Change the non-numeric values to all numeric values or change the entire field to blank.

- If correcting your file, update the Member Contribution Rate (Post-Tax) field with a valid value or change to blank. Re-upload into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update the Member Contribution Rate (Post-Tax) field with a valid value or change to blank. Upload a new file into SEW.

Error Message ID: 30301085

Legacy Error ID: MO-I026

Error Description: The Member Contribution Amount (Post-Tax) does not contain a valid numeric value (signed or unsigned).

Error Resolution: The Member Contribution Amount (Post-Tax) field value is invalid, or does not contain valid signed/unsigned value.

The entire Member Contribution Amount (Post-Tax) field must contain valid signed*/unsigned values or be blank. Valid Member Contribution Amount (Post-Tax) field value must have all signed values in uppercase per Table 1: Signed values conversion table below. A valid Member Contribution Amount (Post-Tax) field value can be blank.

The entire Member Contribution Rate (Pre-Tax) field must contain either all numeric values (i.e., 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) or be blank.

• If correcting your file, update the Member Contribution Rate (Pre-Tax) field with a valid value

or change to blank. Re-upload into SEW.

Error Description: The Member Contribution Amount (Pre-Tax) does not contain a valid numeric value (signed* or unsigned).

The entire Member Contribution Amount (Pre -Tax) field must contain valid signed*/unsigned values or be blank. Valid Member Contribution Amount (Pre -Tax) field value must have all signed values in uppercase per Table 1: Signed values conversion table below. Error Message ID: 30301086

Legacy Error ID: MO-I030

Error Description: The Line Count does not contain a valid numeric value.

Error Resolution: The Line Count field does not contain a valid number.

The entire Line Count field can only contain numbers (i.e., 1, 2, 3, 4, 5, 6, 7, 8, 9, 0).

- If correcting your file, update the Line Count field with numeric values. Re-upload corrected file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update the Line Count field with numeric values. Upload a new file into SEW.

Field(s) and Record Position(s): Line Count (5-10)

Error Message ID: 30301089

Legacy Error ID: MO-I041

Error Description: Base Hours does not contain a valid numeric value.

Error Resolution: The Base Hours field contains non-numeric characters (blank allowed).

The entire Base Hours field must contain either all numeric values (i.e., 1, 2, 3, 4, 5, 6, 7, 8, 9, 0) or be blank.

- If correcting your file, update the Base Hours field to all numeric values or blank. Re-upload corrected file into SEW.
- If correcting your payroll system, make the appropriate changes in your payroll system to update the Base Hours field to all numeric values or blank. Upload a new file into SEW.

Field(s) and Record Position(s): Base Hours (103-108)

2.1 F496 Business Errors and Resolutions

Error Message ID: 30301126

Legacy Error ID: MO-I005

Error Description: Contribution Code is 4 and Earnings is not zero.

Error Resolution: Contribution Code 4 is not reported with zero Earnings. Earnings must be zero if the contribution line is reported with Contribution Code 4 (Receivable: payroll deduction for CalSTRS payment).

Verify that the Contribution Code being reported is accurate. Change the Contribution Code if inaccurate or change the reported earnings to zero.

- If correcting onscreen in SEW, change the appropriate field in the Employer Payroll Detail record and revalidate the record.
- If correcting your payroll system, make the appropriate changes in your payroll system. Upload a new file into SEW.

Field(s) and Record Position(s): Contribution Code (57), Earnings (46-52)

Error Message ID: 30301127

Legacy Error ID: MO-I011

Error Description: Member Contribution Amount (Pre-Tax) and Member Contribution Amount (Post Tax) are both greater than zero.

Error Resolution: Both the Member Contribution Amount (Pre-Tax) and the Member Contribution Amount (Post Tax) fields are populated in the payroll detail record.

Determine if the contribution line should contain a Pre-Tax amount or Post- Tax amount and report accordingly. A contribution line cannot be populated with <u>BOTH</u> a Pre-Tax and Post-Tax amount.

- If correcting onscreen in SEW, update the corresponding Reported Amount in the Employer Payroll Detail record and revalidate the record.
- If correcting your payroll system, make the appropriate changes in your payroll system. Upload a new file into SEW.

If the Pre-Tax and Post-Tax amounts are valid, you will need to report more than one contribution line. CalSTRS does not accept contribution lines with BOTH a Pre-Tax and Post-Tax amount.

Field(s) and Record Position(s): Member Contribution Amount (Post-Tax) (58-63), Member Contribution Amount (Pre-Tax) (95-100)

Error Message ID: 30301128

Legacy Error ID: MO-I014

Error Description: Member code is not equal to 1 (member) or 2 (non-member).

Error Resolution: The Member Code must be either a "1" (member) or a "2" (non-member).

- If correcting onscreen in SEW, change the Member Code to a "Member" or "Non-Member" in the Employer Payroll Detail record and revalidate the record.
- If correcting the file or your payroll system, make the appropriate changes to a "1" (Member) or a "2" (Non-member). Upload a new file into SEW.

Field(s) and Record Position(s): Member Code (34)

Error Message ID: 30301101

Legacy Error ID: MO-I022

Error Description: Employee Social Security Number cannot have repeating characters.

Error Resolution: The Employee Social Security Number contains all repeating characters.

Employee Social Security Number cannot contain all repeating characters (i.e., 55555555).

- If correcting onscreen in SEW, change the SSN in the Employer Payroll Detail record and revalidate the record.
- If correcting your payroll system, make the appropriate changes in your payroll system. Upload a new file into SEW.

Field(s) and Record Position(s): Employee Social Security Number (5-13)

Error Message ID: 30301222

Legacy Error ID: MO-I040

Error Description: The Earnings, Member Contribution Amount (Pre-Tax) and Member Contribution Amount (Post Tax) cannot all contain zero or blank amounts.

Error Resolution: The Earnings, Member Contribution Amount (Post-Tax) and Member Contribution Amount (Pre-Tax) fields cannot all contain zeros or blank amounts.

- If correcting onscreen in SEW, change the appropriate fields in the Employer Payroll Detail record and revalidate the record.
- If correcting your payroll system, make the appropriate changes in your payroll system. Upload a new file into SEW.

Field(s) and Record Position(s): Earnings (46-52), Member Contribution Amount (Post-Tax) (58-63), Member Contribution Amount (Pre-Tax) (95-100)

Error Message ID: 30301129

Legacy Error ID: MO-I045

Error Description: Pay Period Fiscal Year not on database.

Error Resolution: The Contribution Line has a Pay Period Begin date or Pay Period End date before fiscal year 1945-46.

Verify the Pay Period Begin date or Pay Period End date is not before fiscal year 1945-46. Change the Pay Period Begin and End dates if incorrect.

- If correcting onscreen in SEW, change the appropriate fields in the Employer Payroll Detail record and revalidate the record.
- If correcting your payroll system, make the appropriate changes in your payroll system. Upload a new file into SEW.

Field(s) and Record Position(s): Pay Period Begin (64-71), Pay Period End (72-79)

Error Message ID: 30301011

Replaces Legacy Error ID: MO-B001

Error Description: Member does not exist in System, a new Enrollment is required to be posted for further processing the Payroll detail.

Error Resolution: Employee Security Number does not match an existent Client ID.

Verify Employee Social Security Number:

- If incorrect use the online correction feature in SEW and revalidate the payroll detail record or make the changes in your payroll system and upload a new file.
- If correct establish an account by enrolling the employee into CalSTRS system in one of the following methods:
